Withdrawal Fees	If a family un-enrolls after Aug. 1st- Sept. 30th, their FACTS account will be charged a non-refundable \$300 per student within 10 days of withdrawing. If not paid, late fees and returned payment fees will accumulate until reconciled.		

### **Non-Discrimination Policy**

Genesis Prep Academy admits students of any race, color and national or ethnic origin to all the rights, privileges, programs, and activities generally accorded or made available to students at the school. It does not discriminate on the basis of race, color, and national or ethnic origin in administration of its educational policies, admission policies, scholarship and loan programs, and athletic and other school-administered programs.

### **Payment Policy**

- Financial accounts can be seen and paid online 24/7 on <a href="www.factsmgt.com">www.factsmgt.com</a> or through the Jaguar App.
- Monthly invoice reminder statements will be emailed 10 days prior to the due date by FACTS management if an email is on file. Payments are auto drafted on a monthly basis.
- Monthly tuition is due on the 1st and late after the 5th of the month, Unless other arrangements are made with the Student accounts coordinator.
- Unpaid accounts are assessed a \$25 late fee each month. FACTS management will automatically add the \$25 late fee to be paid the next month and the fee will show on the following month's invoice. Returned payments will have a \$20 fee from FACTS in addition to the late fee.
- If a K-12 student is not enrolled beyond 30 days, no further tuition obligation will be incurred. After 30 days of enrollment, commitment to pay the full tuition of the current semester is required.
- A preschool student is required to give 30 days notice and is required to pay tuition for that 30 days.
- Chronically overdue student accounts may result in dismissal from the school until accounts are brought current. All accounts must be in good standing at the end of 1st semester in order to continue enrollment in 2nd semester. Families are encouraged to stay in contact with GPA Student Accounts Coordinator regarding financial concerns or outstanding balances.
- Should a student transfer out of Genesis Prep, all academic records will be held until the student/family is in good financial standing.

#### **GPA Volunteer Credit**

Genesis Prep would like to thank our family volunteers with a \$200 tuition credit for their applicable service during the current school year and will be awarded a one-time \$200 credit towards tuition or early registration.

- Families receiving grant & aid are not eligible for the \$200 volunteer credit
- Families receiving 50% or greater reduction in tuition are not eligible for a tuition credit.
- Volunteer credits have no cash value
- Credits will be applied to tuition accounts after written verification is received in the student accounts office.

#### FACTS Grant & Aid/Church staff discount

- FACTS Grant & Aid Assessment conducts the financial need analysis for Genesis Prep Academy. Online applications are available at <a href="https://www.genesisprep.org/grant&aid">www.genesisprep.org/grant&aid</a> and require a \$40 submission fee.
- Each year requires a new application to be submitted (no automatic renewals) for K-12 students.
- Criteria for assistance: "Total tuition exceeds 10% of total income from all sources. For example, a family with 1 elementary student at \$6,400 tuition would need to have a total income of less than \$64,000.
- Grant & Aid is awarded based on need and availability at the discretion of the Grant & Aid committee.
- There is a limited amount of Grant & Aid available.
- All families awarded Grant & Aid are asked to complete volunteer hours during the school year. Failure to complete 40 hours, may jeopardize your qualifications for the following year.
- All Grant & Aid applications & awards are confidential. Failure to maintain confidentiality on the part of a family is grounds for nullification of the award.
- Preschool Grant & Aid is handled through the state of Idaho (ICCP). Please see the Preschool Director.

Full time church staff discount is awarded when the primary income earner of the family is employed by a Church. These families are not eligible for further assistance, including but not limited to multiple child discounts and Grant & Aid. K-12 receives 50%, PreK receives 10%.
